Tax deadline extended due to storm

WASHINGTON, D.C. — The IRS has granted an additional weeklong extension to the federal tax-filing deadline to taxpayers affected by the recent storm. IRS Commissioner Mark Everson granted the additional week federal extension after Sen. Charles Schumer requested it at a Senate Finance Committee hearing Wednesday morning. Earlier this week, the IRS granted a two-day extension for storm ravaged regions in New York and across the Northeast. Ongoing power outages and public transportation problems have made it difficult in some cases, if not impossible, for some taxpayers and tax professionals to meet the April 17 filing deadline, according to a news release from Schumer's office. Affected taxpayers can mark their paper tax returns with the words "April 16 Storm." Taxpayers who e-file their returns can use their software's "disaster" feature, if available.

More drunken-driving stops made in March

PLATTSBURGH — Clinton County STOP-DWI officials report 42 drunken-driving arrests made in March, with an additional four incidents of driving with ability impaired. According to the monthly statistics, 897 speeding tickets were issued across the county, with 92 additional tickets for cell-phone use while driving and 76 tickets for aggravated unlicensed operation of a motor vehicle. So far in 2007, 121 DWI offenses have been documented, with six additional incidents of DWAI. Those numbers were compiled from data submitted by the New York State Police, Clinton County Sheriff's Department, Plattsburgh City Police, New York State Park Police and University Police.

Keeseville schedules brush pickup day
